# Federal Budget 2020

## \$1.1 BILLION FOR SHOVEL-READY PROJECTS IN VICTORIA

Rebuilding our economy includes building more roads, rail and bridges. This Budget is expanding its 10 year infrastructure pipeline which is already supporting 100,000 jobs on worksites across Australia today.

As part of our Economic Recovery Plan, the Morrison Government has committed an additional \$7.5 billion in new investments in national transport infrastructure, including \$1.1 billion right here in Victoria.



## **TAX RELIEF FOR 11 MILLION AUSTRALIANS**

More than 11 million taxpayers will get a tax cut backdated to 1 July this year. Lower and middle-income earners will, this year, receive tax relief of up to \$2,745 compared with 2017-18.

We will also retain the Low and Middle Income Tax Offset for an additional year. The changes mean more than 7 million Australians will receive tax relief of \$2,000 or more this year.

This rewards hard work. It means Australians will have more of their own money to spend on what matters to them, which will help local businesses and create more jobs.





## **SUPPORTING SENIOR AUSTRALIANS**

To support Age Pensioners, the Government provided \$750 payments in April and July. Age Pensioners will now receive an additional \$250 payment in December and another \$250 payment in March.

To support senior Australians who want to keep living at home, an additional 23,000 home care packages will be provided. This brings the total to more than 180,000 places, three times the number of home care packages than when this Government was elected in 2013.



## **INVESTING IN SKILLS AND TRAINING**

100,000 new apprenticeships and traineeships will be supported with a 50% wage subsidy for businesses who employ them. This is in addition to the 180,000 existing apprenticeships and traineeships that are being protected.

The new JobTrainer fund will create up to 340,000 free or low-cost training places for school leavers and job seekers. 50,000 new higher education short courses will be available, including in health, IT, agriculture, science and teaching. New cadetships and apprenticeships are being provided for women in science, technology, engineering and mathematics.



### Sharri GOVT PREPARES TO HAND DOWN 2020 BUDGET

#### MODERN MANUFACTURING AND RESEARCH

Australia's manufacturing sector employs around 860,000 Australians. The Modern Manufacturing plan will target six national manufacturing priorities, to build on our strengths and ensure manufacturing plays a greater role in our recovery:

- medical products;
- food and beverage manufacturing;
- recycling and clean energy;

critical minerals processing;

- resources technology;
- defence industry; and
- space industry.

This Budget also provides \$2 billion in additional Research and Development incentives.

The Morrison Government is also providing \$1 billion for new research funding for our universities, backing our best and brightest minds.



## GUARANTEEING HEALTH CARE



The Budget delivers record funding for health in 2020-21 of \$938 billion, an increase of almost 43% since 2014-15. Extending Medicare subsidised telehealth services has enabled over 30 million consultations since the crisis began.

This Budget includes funding for new lifesaving medicines on the Pharmaceutical Benefits Scheme – to treat leukaemia, melanoma and Parkinson's disease and help women with ovarian cancer.

This year, \$5.7 billion is being provided to support mental health, including funding for critical front line services, suicide prevention, and doubling the number of Medicare funded psychological services through the Better Access Initiative, from 10 to 20.

## PROTECTING OUR ENVIRONMENT

This Budget includes \$1.9 billion in new funding as part of the Government's energy plan to support low emissions and renewable technologies. It includes a further \$1.8 billion in funding for the environment. This will help our wildlife recover from bushfires and protect and enhance our natural environment.

This Budget is investing \$250 million to modernise our recycling infrastructure, stop more than 600,000 tonnes of waste ending up in landfill and create a further 10,000 jobs.



## ECONOMIC RECOVERY PLAN FOR AUSTRALIA

COVID-19 has resulted in the most severe global economic crisis since the Great Depression. Across the world, the equivalent of 600 million people have lost their inches.

In response to this crisis, the Morrison Government has committed unprecedented support to save lives, cushion the blow and help Australians remain in jobs. JobKeeper is a \$101 billion lifeline that is supporting around 3.5 million jobs. JobSeeker doubled the safety net.

Together, our actions saved 700,000 jobs. We could do this because we entered this crisis in a position of strength, brought the Budget back to balance for the first time in 11 years and maintained our AAA credit rating.

Australia's economy is fighting back. More than half of those who lost their jobs are back at work. However, there remains a monumental task ahead.

This Budget sets out the next phase of our Economic Recovery Plan.



## **CROYDON STATION CARPARK**

At the last election I secured funding from the Federal Government to provide a new multi-level carpark at Croydon train station. With the easing of Covid-19 restrictions, it is very exciting to see site works commencing! The carpark will be constructed on Council owned land at Devon Street, Croydon and is expected to be completed by October 2021. Maroondah City Council will provide alternative carparking arrangements in Croydon, as required, during construction.

The centrepiece of the Budget, a \$74 billion JobMaker plan forms a key part of our Economic Recovery Plan to create jobs, rebuild our economy and secure our future.

JobMaker includes a new \$4 billion hiring credit that will provide an incentive to businesses who take on additional employees aged between 16 and 35. It is estimated that the scheme will support around 450,000 jobs.

There will also be an additional \$1.2 billion to the Boosting Apprenticeships Wage Subsidy to support up to 100,000 new apprentices and trainees.



## **EXPANDING THE INSTANT ASSET WRITE-OFF**

We are expanding the successful Instant Asset Write-off scheme for businesses with a turnover of up to \$5 billion until 30 June 2022. This means that the scheme will now be available to 3.5 million businesses that employ 11.5 million

Together with our proposal to allow companies to offset tax losses against previous profits and tax paid, these measures are estimated to deliver \$31.6 billion in tax relie to businesses. This will support around \$200 billion of investment, creating 50,000 additional jobs.

## **FIRST HOME LOAN DEPOSIT** SCHEME EXTENDED

In my role as the Minister for Housing, I recently announced that an additional 10,000 places will be provided through the scheme this year for first home buyers who build a new home or purchase a newly built one.

The expanded scheme will provide more Australians with the chance to own their own home while generating more than \$1.5 billion of additional economic activity in the residential construction sector.

We're also simplifying lending laws to reduce the time it takes for consumers to apply for credit by reducing the regulatory burden on consumers and lenders.
